Categories for Judging

Heritage Costume Showcase

Talent

Contestants will be required to have a prepared talent which will be performed on stage while wearing a casual dress outfit (representing talent) and considered as part of their overall score.

Formal Wear

All contestants are responsible for the provision of their own formal attire to showcase their grace and elegance. All shoes and accessories provided by contestants.

Question & Answer

All finalist must participate in an on stage interview at the time of the formal scene.

Awards

All contestants will receive a participation award, in addition to the 1st Place, 2nd Place, & 3rd Place prizes. ***All 1st place recipients are required to attend community functions to represent the Rochester West Indian Festival Organization, Inc (RWIFO).*** ALL participants will be required to attend community activities as part of the process as a Miss Carifest contestant.

PAGEANT RELEASE FORM
